By signing this Waiver and Liability Release Form, I acknowledge and understand that participation in off-road motorcycling and ATVing at Breezewood Proving Grounds Inc. is an extremely dangerous sport, for both participants and observers. I understand that hazards may exist on or around the track, which may include, but is not limited to, areas that are steep, wet, slippery, rocky, sharp turns and/or natural and man-made obstructions, or combinations of these. I understand that I could be riding with other riders of different skill levels, and that both motorcycles and ATV's might be occupying the tracks at the same time. I understand that the courses I will be riding on, or observing, will have both motorcycles and ATV's that could be jumping as high, or higher, than 50 feet, and as far or further then 110 feet. In addition to the risk of injury to active motorcycle and/or ATV riders, caused by other riders or course hazards, I understand that there are risks to bystanders and observers from flying debris and/or motorcycles, or riders leaving the course out of control. I understand that the injuries that may be sustained by participants or observers include, but are not limited to, broken bones, lacerations, internal injuries, blunt trauma, burns, paralysis and death. I further understand that Breezewood Proving Grounds Inc. does not employ any medical staff, and that there are no medical personal or an ambulance on site. The nearest hospital is approximately forty-five minutes by car from the park. I know that as an observer or bystander, I can not rely on any barricade or any barrier to protect me from injury. I must rely on my own judgement as to my safety in positioning myself, and I assume all the risk of injury to myself and or damage to my property while at Breezewood Proving Grounds Inc.

I AGREE NOT TO HOLD BREEZEWOOD PROVING GROUNDS INC. IT'S EMPLOYEES, OFFICERS, OR ANY OWNERS OF REAL ESTATE ON WHICH BREEZEWOOD PROVING GROUNDS INC. CONDUCTS BUSINESS, RESPONSIBLE IN ANY WAY FOR INJURIES THAT I MAY SUSTAIN AS A RESULT OF MY PARTICIPATION IN THE SPORT OF OFF ROAD RIDING, OR OBSERVATION OF OFF ROAD RIDING, WHILE AT BREEZEWOOD PROVING GROUNDS, INC. I WILL NOT FILE SUIT AGAINST BREEZEWOOD PROVING GROUNDS INC., IT'S EMPLOYEES, OFFICERS, ITS MEMBERS, OR ANY OWNERS OF REAL ESTATE ON WHICH BREEZEWOOD PROVING GROUNDS INC. OPERATES.
