By Signing this waiver and liability release form I acknowledge and understand that participation in off-road motorcycling and atving at Breezewood Proving Grounds Inc. is an extremely dangerous sport both for participants and observers. I understand that hazards may exist on or around the track which may include but are not limited to: steep areas, wet areas, deep holes, slippery areas, rocky areas, sharp turns, natural and man-made obstructions and combinations of these areas. I understand that I will be riding with other riders of different skill levels, and that both motorcycles and atv's will be occupying the tracks at the same time. I understand that the courses I will be riding on or observing will have both motorcycles and atvs that could be jumping as high or higher then 50 feet and as far or farther then 110 feet. In addition to the risk to active participants in being injured in motorcycle & atv crashes caused by course hazards or other riders, I understand that there is risks to bystanders and observers from flying debris and motorcycles or riders leaving the course out of control. I understand that the injuries that may be sustained by participants or observers include, but are not limited to, broken bones, lacerations, internal injuries, blunt trauma, burns, paralysis, and death. **I further understand that Breezewood Proving Grounds Inc. does not employ any medical staff that there are no medical personal on site and there is no ambulance on site. The nearest hospital is approximately forty-five minutes from the park by car.** I know that as an observer, I can not rely on any barricade or any barrier to protect me from injury. I must rely on my own judgement as to my safety in positioning myself, and I assume all the risk of injury to myself and or damage to my property while at Breezewood Proving Grounds Inc. I understand that the property has several water ponds that may present dangers. As a visitor to the park I assume all liability for myself and my children. I understand that the facility has no life guards on duty and if I choose to swim in the water I do so at my own risk. I acknowledge the dangers of drowning and assume that risk on my own.

I AGREE NOT TO HOLD BREEZEWOOD PROVING GROUNDS INC. IT'S EMPLOYEES, OFFICERS, OR ANY OWNERS OF REAL ESTATE ON WHICH BREEZEWOOD PROVING GROUNDS INC. CONDUCTS BUSINESS RESPONSIBLE IN ANY WAY FOR INJURIES THAT I MAY SUFFER AS A RESULT OF MY PARTICIPATION IN THE SPORT OF OFF ROAD RIDING OR OBSERVATION OF OFF ROAD RIDING, OR SWIMMING, WHILE AT BREEZEWOOD PROVING GROUNDS, INC. I WILL NOT FILE SUIT AGAINST BREEZEWOOD PROVING GROUNDS INC. IT'S EMPLOYEES, OFFICERS, ITS MEMBERS, OR ANY OWNERS OF REAL ESTATE ON WHICH BREEZEWOOD PROVING GROUNDS INC. OPERATES.
